



Asheville Head Neck & Ear Cuts Patient Intake Time by 87%

While Otolaryngology — the study of ear, nose, and throat conditions — may be a mouthful for most people, it is second nature for the staff of Asheville Head, Neck & Ear Surgeons. A widely respected clinic with facilities throughout North Carolina, Asheville Head, Neck & Ear Surgeons (AHNE) is committed to providing all patients with respectful, quality medical care, and often looks to technology for solutions that streamline operations to enhance patient care.

Challenge

At check-in, AHNE collected HIPAA consent for treatment, insurance authorization, and patient practices & policies forms from each patient. They also collected treatment consent forms on the clinic floor, but in both instances the process was taking too long. It could take patients up to 15 minutes to complete the forms, and more staff time to make copies, re-key data, scan forms, and attach the resulting PDF to the patient's medical record. The originals were then disposed of through a shredding company. Errors were introduced when patients missed a field, or staff re-keyed data incorrectly or attached a PDF to the wrong patient's chart. "We had at least two staff members touch each form and three entities for proper disposal," said IT Manager Sam Clark. "And shredding paper is not as cheap as you might think." AHNE needed a better way.

Solution

AHNE saw an opportunity to use electronic signatures to drastically improve the process and minimize patient burden. After looking at several vendors and in-house solutions, Clark and the team chose DocuSign for Patients, a patient on-boarding solution developed in partnership with Kryptiq, to digitize their workflow. AHNE has collapsed its three check-in documents down to a single form, which the patient fills in and DocuSigns

using an iPad in the waiting room. The solution integrates seamlessly with the existing electronic medical records (EMR) system so data now flows instantly from input to medical records, eliminating manual steps — and errors — from the process. "There is no possibility of a patient forgetting to date or properly sign a document." Clark observed.

Results

With the patient on-boarding solution from DocuSign and Kryptiq, it now takes patients only two minutes — down from 15 — to fill out consent and waiver forms. Through the efficiencies created by the solution, AHNE saved manpower equivalent to one full time employee. What's more, Clark noted that "our paper-related supply costs, including handling and shredding, were reduced by 30% per month."

"We are very happy not only with the product, but also DocuSign's willingness to listen to us, adapt and customize it for our needs and our ideas," according to Clark. "It was a great overall experience." The rollout has been well received, and Asheville Head Neck and Ear Surgeons is planning to expand its implementation to integrate DocuSign with clinical observation data.
